All HSS's of the State are required to complete the Application Verification and Validation as per the timeline mentioned above strictly. They are directed to refer to the Guideline document (and user manual), understand the process involved and complete the Online Junior Merit Scholarship verification process well within the revised timeline using the link available on www.medhabruti.org and <http://samsodisha.gov.in/Juniorweb.aspx> affirmatively.

Further, they are directed to complete the approval process at their HSS/ Institution on a daily basis to avoid backlog and subsequent delays. Strict action will be initiated against the defaulting principals, those who will not follow the instruction and dateline.

This is to be treated as most urgent since no further extension will be made beyond this dateline.
