

**Sub: Guidelines & Timeline for Phase-II admission in Degree  
Colleges (+ 3 1<sup>st</sup> Year) for the session 2020-21**

Madam/ Sir,

In inviting a reference to the subject cited above, I am directed to inform you that the Phase-II admission of U.G Class (+3 1<sup>st</sup> Year) under SAMS will be held as per the guidelines mentioned below:

1. Those who have not submitted CAF during Phase-I can submit fresh application for Phase-II and have to deposit the CAF fees online.
2. Applicants/ students who have already taken admission/ not taken admission during Phase-I can also apply for Phase-II admission. They are not required to deposit CAF fees again.
3. There will be reservation in the category of SC, ST, ESM/SDP/CoM in respect of vacancies available in different colleges/ subjects.
4. There will be weightage for applicants/students in the categories of NCC, NSS, Rover & Ranger, Sports & Games as per Common Prospectus.
5. Selection of the applicants/students will be done purely on the mark basis. However applicants/students with physical disability (PwD) will be given first priority irrespective of the marks in all categories.




